

LPG CHANGEOVER TRAINING & ASSESSMENTS

Introduction:

The Nationally Accredited Certification Scheme for Individual Gas Fitting Operatives (ACS) is designed for individuals who already hold a recognised qualification, and will fall into one of the two categories below:

- **RE ASSESSMENT** – Candidates whose existing qualification of competence is due to expire or has expired within 6 months of the expiry date.
- **INITIAL ASSESSMENT** – Candidates who hold a current Gas Diploma / Foundation certificate and are completing ACS for the first time, or candidates who hold an existing ACS certificate of competence but has expired over 6 months of expiry date.

The LPG changeover assessment programme that we offer has been approved by the Gas Industry Standard Setting Body, Energy and Utility Skills, and is fully certificated by Cert-ain certification ltd.

Eligibility:

All candidates will need to hold the relevant qualifications / certificate of competence, and a copy of this must be provided to the training centre, prior to assessments taking place. If you have lost, or misplaced your certificate, please give us a call and we can help you in getting a replacement certificate.

Course Content:

We offer a full refresher training and assessment programme for the LPG Changeover. Duration of these may vary, according to how many elements you are undertaking. Please contact us for more information.

*Please note that training is not a prerequisite for assessment.

Elements Available:

We offer 3 main elements for the LPG changeover:



PD - Permanent Dwellings



RPH – Residential Park Homes



LAV – Leisure Accommodation Vehicles

We also offer the **HTRLP2** assessment (Closed Flue Type Fires)

Training & Assessment Methods:

Candidates will be assessed by both practical, and theory with short written response and multiple-choice answers required, in accordance with the assessment criteria. Additional training can also be given to individual candidates.

Achievements & Progression:

Upon successful completion of the ACS assessments, candidates will be able to register themselves, or their business, with the Gas Safe Register.

Progression routes are available to candidates once registered with Gas Safe, and can include the following:

- Additional Gas Appliances (Boilers, Cookers, Fires, Meters, Warm Air)
- LPG Changeover (Domestic, Residential Park Homes, Caravans /Motorhomes /Boats)
- Commercial Gas Changeover (Heating)
- Commercial Gas Changeover (Catering)
- Boiler Fault Finding and Essential Electrics
